JOB DESCRIPTION FACILITIES MANAGER

Job Purpose and Summary:

The purpose of this role is to lead the Facilities Management, and the health & safety, across Make CIC's portfolio of projects in the Liverpool City Region. Make CIC operates a number of different buildings and land for the benefit of its community of interest. This is a mix of owned, rented, meanwhile and pop-up with many sub-letting arrangements.

Our mission is to **run a secure**, **well-managed estate** of welcoming creative spaces and places - both within our own hubs and by supporting others to activate and manage buildings, land, and property in their communities. We are committed to keeping spaces affordable and accessible to sustain grassroots creativity and enterprise.

This role is critical to that mission so that we deliver our duties in relation to the safe and compliant use of buildings and land in a way that is appropriate for the tenancy type.

Duties will include scheduling planned repairs and maintenance, dealing with responsive repairs and maintenance, delivering statutory duties such as scheduling regular alarm testing, access, and risk assessments, and some high level property management compliance areas such as EICR tests, boiler inspections, LOLER reports, and compliance with other "big six" areas.

This role will hold and maintain relationships and contracts with Make CIC's suppliers, seeking to achieve best value, and pro-bono support where possible, in line with our social mission of keeping spaces affordable and accessible. Additionally the role will be the budget holder for lines related to building running costs. This includes managing property expenditure, such as utilities and service contracts - working closely with the Community Managers in their operational duties and the finance roles in theirs.

Make CIC is a place-based community interest company that owns, leases, and manages land and property for the benefit of its community of interest and the benefit of the places it operates, within the Liverpool City Region.

Across a number of different use types, Make CIC brings people together in buildings and on land with the aim to be accessible and affordable for its users. The organisation is also involved in supporting other pro-social, voluntary, community and charitable organisations with challenges around land and property.

Make CIC is working with national partners and funders, such as Power to Change and Kindred, as well as local partners and funders, such as the Leftback Collective, the

Local Councils, and Combined Authority. Make is leading the way on innovative place-based regeneration work - and this role is to help manage the land and property associated with that work.
